Dear Mr. Stalter:

As part of its annual legislative review process and in cooperation with Missouri legislators, the Missouri State Board of Embalmers and Funeral Directors (the "Board") will be conducting a review of Missouri's preneed laws/regulations. To assist in this review, the Board has established a review team consisting of consumer representatives and various representatives of the funeral, insurance and preneed industries.

The review team will be conducting an in-depth review of Chapter 436 of the Revised Statutes of Missouri, which governs preneed sales. While the Board understands the varying opinions regarding preneed, the goal of the Board is to develop a consensus of Chapter 436 changes that will help clarify our laws and better protect Missouri citizens.

The Board would like to complete its review on or before early August. To meet this goal, it is anticipated that the review team will have several meetings. All meetings will be posted and open to the public. At this time, it appears that all meetings will be held at the following location in Jefferson City, Missouri.
